BGR and Foster Wheeler enter Collaboration for Complete Range of PC Boilers

New Delhi, 1st April, 2009, BGR Energy Systems Limited (BGR Energy), through a Special Purpose Company Viz., BGR Boilers Private Limited, has entered into a Licence Agreement with Foster Wheeler North America Corp., a subsidiary of Foster Wheeler's Global Power Group having its operational headquarters at New Jersey, USA.

The Licence Agreement grants to BGR Boilers an exclusive licence and rights for the Indian Market to design, manufacture and sell:

- (a) Sub-critical coal fired Steam Generators (Boilers)
- (b) Super-critical coal fired Steam Generators (Boilers)

Typical Unit sizes would be 300 MW, 500 MW, 600 MW, 660 MW, 800 MW and 1000 MW. BGR Boilers will have access to international markets via case-by-case licence. The 20 year licence agreement is subject to approval of the Government of India.

This license agreement is a significant step forward for BGR group and Foster Wheeler. This will also support Government of India's vision for sustained growth of power sector duly backed by domestic manufacture of power plant equipments. BGR group will also emerge as one of the select list of group with both manufacturing and EPC capabilities.
