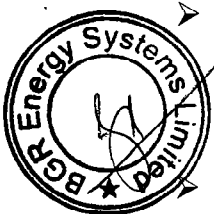

- Revenues stood at ₹ 821.30 Crore, growing by 34.43% over ₹ 610.94 Crore
- Construction and EPC contracts segment contributed 96% to the revenues, growing by 38% at ₹ 787.43 Crore compared to ₹ 568.59 Crore in the first quarter of FY 2012-13
- EBIDTA grew by 20.44% at ₹106.06 Crore over Q1 of last year which was at ₹ 88.06 Crore
- Achieved Profit Before Tax (PBT) of ₹ 56.61 Crore registering a growth of 13.61% over ₹ 49.83 Crore
