# BGR Energy awarded Chandrapur Mega Project contract for Rs. 1632 Crores

Chennai, July 13, 2009: BGR Energy Systems Limited ('BGR Energy'), the EPC Company for Power projects, has secured a Turnkey EPC of Balance of Plant (BOP) contract from Maharashtra Power Generation Corporation (MAHAGENCO) for execution of the 2 X 500 MW Chandrapur Super Thermal Power Station (STPS) Expansion Project at Chandrapur, Maharashtra. The contract is valued at Rs.1631.80 Crores and it will be completed over 33 months.

The BOP contract scope includes Design, Engineering, Supply, Erection, Testing and Commissioning of all Balance of Plant Mechanical, Electrical and Civil and structural works for the Main plant and BOP. BGR Energy was successful against stiff competition from seven bidders including TATA Projects and L&T. It is the second consecutive BOP contract from MAHAGENCO, as BGR Energy has in 2007, bagged the 500 MW Khaperkheda Expansion Project near Nagpur. The Khaperkheda Project is now under construction.

The Coal-based Chandrapur STPS Project has 2340 MW Power generation capacity, as on date. This Project enjoys the 'Mega Power Project' status and the MAHAGENCO has tied-up with Rural Electrification Corporation (REC) to finance this Project.

Over the years, BGR Energy has emerged as the market leader in Balance of Plant segment business for Power Projects in India. The Company has to its credit successful completion of four prestigious BOP contracts viz., 500 MW Vijayawada Thermal Power Plant for APGENCO, Andhra Pradesh, 95 MW Valuthur Combined

Cycle Power Plant (CCCP) for TNEB, Tamil Nadu, 330 MW Dholpur Power Project (CCCP) for RVUNL, Rajasthan and 23MW CCCP for Aditya Cements, Rajasthan. Currently, BGR Energy is executing two more BOP packages for Thermal Power Plants of 500 MW each, at Warangal and Kothagudem of Andhra Pradesh for APGENCO, apart from the Khaperkheda Expansion Project, Nagpur. The Company is executing EPC contracts for 600 MW projects in Rajasthan and Tamil Nadu.
