**Disclosure under Regulation 30 of Securities and Exchange Board of India  
(Listing Obligations and Disclosure Requirements) Regulations, 2015**

BGR Energy Systems Limited (the "**Company**") has entered into an Agreement (the "**Agreement**") with Hitachi, Ltd., Japan (HTC) and Hitachi Power Europe GmbH, Germany (HPE) on 30<sup>th</sup> March, 2016 at Tokyo, Japan. The Agreement has come into effect and has become legally binding with effect from 29<sup>th</sup> April, 2016 upon fulfilment of the conditions mentioned therein.

The Agreement, *inter alia*, provides for, execution of NTPC contracts for Solapur (2 x 660 MW) and Meja (2 x 660 MW) of Supercritical Steam Generators (Boilers) and Lara (2 x 800 MW) Supercritical Steam Turbines and Generators (STG) (collectively referred to as "**NTPC Projects**") and for certain arrangement with respect to the future of the JV relationship between HTC, HPE and the Company in respect of the existing Joint Venture companies viz., BGR Boilers Private Limited and BGR Turbines Company Private Limited after completion of the NTPC Projects in compliance of the NTPC contract and other related conditions.

These Joint Venture Companies were formed in the year 2010 for technical and financial collaboration for manufacture of super critical boilers and steam turbines and generators.

The Agreement provides for certain payments to be made by HTC to the Company in a phased manner over a period of time on achievement of number of milestones/events/transactions so as to realise the objectives mentioned hereinabove.
