**FINANCIAL RESULTS OF BGR ENERGY  
FOR THE QUARTER ENDED 30<sup>TH</sup> JUNE, 2009**

**Chennai, July 25, 2009 :** BGR Energy Systems Limited ('BGR Energy'), the EPC Company for Power projects, has reported Sales revenue of Rs. 311 Crore for the quarter ended 30<sup>th</sup> June 2009. The Company has posted impressive gains in terms of EBIDTA, Net profit and EPS during the first three months of the current financial year.

EBIDTA surged to Rs. 42.23 Crore as against Rs. 31.16 Crore during the same period, accounting for a growth of 36%.

Net profit of the Company has clocked a rise of 17.4%, from Rs. 17.23 Cr in the Q1 of FY '09 to Rs. 20.24 Cr for the same period in FY '10.

EPC contracts segment has contributed a significant Rs. 294.10 Cr to the Company's revenue during the first quarter.

EPS of BGR Energy Systems Limited has improved by 17.6 % up in the first quarter of FY '10, as compared to the same period of '09. The Basic EPS after extraordinary items has enhanced to Rs. 2.81 from Rs. 2.39 in Q1 of FY '09.
