**Chennai, 1<sup>st</sup> July, 2008.** BGR Energy Systems Limited ("BGR Energy"), Chennai has bagged the EPC contract for the 1 x 600 MW from Tamil Nadu Electricity Board. This project is an expansion of the existing 4 x 210 MW Thermal power project of TNEB at Mettur. The total contract value of the project is Rs.3100.06 Crores. The scope of work consists of Design, Engineering, Supply of Boiler, Steam Turbine Generator and complete Balance of Plant equipments inclusive of all mechanical, electrical, instrumentation & control systems and civil, structural and architectural works, necessary for putting into commercial operation on Engineering, Procurement and Construction (EPC) basis.

Earlier, TNEB had pre-qualified the bidders for the project through an International Competitive Bidding. The only other bidder was BHEL. It may be noted that with this order the Company has successfully forayed into EPC contract segment for large projects of 500 MW and above with the likes of BHEL and Reliance Infrastructure.
