# Deaths of Missing in Iraq

Minister of State for External Affairs K Singh would travel to Iraq to bring back the mortal remains on a special plane, she said. It will stop in Amritsar where 31 bodies of victims from Punjab and four from Himachal Pradesh will be handed over to relatives. It will then travel to Patna and then to Kolkata.

Expressing grief over the deaths, leader of the Opposition Ghulam Nabi Azad sought to remind the government that "assured us last year that the missing were alive". The senior Congress leader said the government is not making efforts to ensure the missing were safe, and discussed the Budget, the Punjab National Bank fraud case, special category status to Andhra Pradesh and formation of the Cauvery Management Board. While the rest of the Opposition wanted Azad to make a statement, members belonging to the PDM and the ADMK and those from the Andhra Pradesh parties, entered the Well of the House.

## US TRADE MOVES MAY ESCALATE AS OTHERS RETALIATE: AZEVEDO



Recent decisions by the US to unilaterally raise tariffs and target the rules-based regime of the World Trade Organization (WTO) may very well escalate into a potential global trade war, WTO Director-General Roberto Azevedo (pictured) said on Tuesday. "The WTO does not, as an institution, take a stance. But I'm very concerned because of these measures. Because, whatever reasons has a very real possibility of escalation because of the possibility of responses from other partners with trade restrictive measures as well," Azevedo said.
